

TERMS AND CONDITIONS OF ENTRY

Frocktober 2025 Major Prize Draw

The following are the terms and conditions of entry (“the **Competition Terms**”) to the Frocktober 2025 Major Prize Draw (“the **Competition**”) for the Ovarian Cancer Research Foundation’s Frocktober campaign (“the **Event**”). By entering or accepting an entry to the **Event** via the Ovarian Cancer Research Foundation (“**OCRF**”) registration system and/or the website <https://www.frocktober.org.au/register-now>, you hereby acknowledge your acceptance of the **Competition Terms**.

The **Competition Terms** govern **OCRF**’s competition for the chance to win one of three prizes (“the **Prizes**”) being a year’s supply of Darrell Lea products and a \$1,000 Visa eGift Card (“**1st Prize**”) valued in total at \$2,200, an A3 original custom illustration by Alexandra Nea (“**2nd Prize**”) valued at \$750 and a \$300 Witchery voucher (“**3rd Prize**”) valued at \$300.

The Prizes

1st Prize: A year’s supply of Darrell Lea products and a \$1,000 Visa eGift Card.

The year’s supply of Darrell Lea is provided in the form of a monthly delivery of Darrell Lea products for 12 consecutive months, after which time deliveries cease. The value of each monthly delivery is \$100. The specific products included in each delivery may vary at Darrell Lea’s discretion. A valid postal address must be provided to the **OCRF** to arrange delivery.

The \$1,000 Visa eGift Card comes in the form of a digital Gift Card, pre-loaded with \$1,000 credit for use wherever a Visa Card payment is accepted.

2nd Prize: An A3 original custom illustration by Alexandra Nea, specifically a single fashion figure fashion style illustration. The winner’s details will be provided to Alexandra Nea. The winner is responsible for contacting Alexandra Nea directly regarding the illustration creation.

3rd Prize: A \$300 Witchery voucher, that can be used exclusively in Witchery stores across Australia and online.

The **Prizes** cannot be exchanged for cash or other forms of credit.

Entry

The **Competition** opens at 12.01am AEST on Monday 18 August 2025 and closes at 11.59pm AEDT on Friday 31 October 2025.

Entry is open to participants in the **Event**.

To be eligible for the Prize draw, participants must:

- a) be a resident of Australia, in any state or territory except Western Australia (“**WA**”) or Australian Capital Territory (“**ACT**”);
- b) be formally registered as a participant in the **Event**, with an active fundraising page; and
- c) have reached a fundraising total of at least \$100 by 11.59pm AEDT on Friday 31 October 2025.

Residents of WA or ACT are not eligible to enter the Competition.

There is no charge to enter the **Competition** and there are no registration fees for participation in the **Event**.

- Entry into the prize draw is automatic once an individual participant reaches a fundraising total of at least \$100
- One additional entry is earned for an individual participant who reaches a fundraising total of at least \$500 by 11.59pm AEDT on Tuesday 30 September 2025
- One additional entry is earned for an individual participant who reaches a fundraising total of at least \$1,000 by 11.59pm AEDT on Friday 31 October 2025

Should a participant in the **Event** meet any of the above criteria and wish to be removed from the **Prize** draw, they must notify **OCRF** in writing via community@ocrf.com.au.

You are not eligible for the **Prize** draw if you are an employee, or partner or immediate family member of an employee of **OCRF** or any third party company or agency directly connected with the creation or administration of the **Competition**.

The Winners

The winners of the **Prizes** will be selected at random via a secure online draw 11.30am AEDT on Monday 10 November 2025. The first name selected at random will be allocated **1st Prize**. The second name selected at random will be allocated the **2nd Prize**. The third name selected at random will be allocated **3rd Prize**. For the avoidance of doubt, once a name is drawn for the **1st Prize** or **2nd Prize**, that name will be removed from the draw and is ineligible to win further prizes.

The winners will be notified by **OCRF** via the email address provided at the time of registering for the **Event**.

Should **OCRF** be unable to contact the winners by 5.00pm AEDT on Thursday 1 January 2026, **OCRF** reserves the right to repeat the selection process and choose replacement winners.

Following the Prize draw, the winners' names will be available upon request by emailing community@ocrf.com.au.

The **OCRF** is not liable for any damages that may occur as a result of:

- Participants entering and/or participating in the **Event**;
- the **Prizes** being lost or damaged (including while the **Prizes** are in transit); or
- use of the **Prizes**.

Personal Information

Any personal information provided in the course of the **Competition** and the **Event** will be subject to these **Competition Terms** and to **OCRF's** Privacy Policy.

You agree that if you are selected as a winner, **OCRF** will:

- use the contact details you provided as part of your entry to contact you; and for the purpose of shipping the **Prizes**.
- If you are a winner, you may also be required to participate in publicity in connection with the **Competition**. You agree that **OCRF** can use your name on social media as "a winner" and in all media and press releases about or reporting on the **Competition**, the **Event** or **OCRF**.

By entering the **Competition**, you agree to your personal information being used for the purposes described in these **Competition Terms**, including the purposes of assessing your eligibility, administering the **Competition**, prize fulfilment, and for contacting you if you are selected as a winner.

Additional Terms

By participating in the **Competition** you warrant that all personal information submitted by you is true, current and complete and that the email address you registered with is accurate and valid.

OCRF reserves the right to cancel the **Competition** and/or amend the **Competition Terms** at any time without prior notice to you where **OCRF** reasonably considers such cancellation or amendment is necessary.

The winners acknowledge that all intellectual property rights belonging to **OCRF**, including but not limited to the Frocktober and **OCRF** logos. Any audio-visual material containing images of the **Competition** winners are and shall remain **OCRF's** sole and exclusive property.

OCRF does not accept responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission or mail delivery, communications line failure, theft, destruction, corruption, alteration of, or unauthorised access to entries, or entries lost or delayed whether or not arising during operation or transmission as a result of server functions, virus, bugs or other causes outside its control.

OCRF shall not have any liability, and do not accept any responsibility, for any damage, loss, injury or disappointment suffered by any participant in this **Competition** or resulting from the **Prizes**.

In the event of any dispute, whether such dispute concerns the conduct or eligibility of participants, results of the **Competition**, or any and all other matters relating to the **Competition**, the decision of **OCRF** shall be final and no correspondence or discussion shall be entered into.

The **Competition Terms** are subject to the law of Victoria, Australia, and the parties irrevocably submit to the exclusive jurisdiction of the Courts of Victoria, Australia.
